Woodland Pulp LLC Wood Procurement Group (Woodland Pulp) supports the Sustainable Forestry Initiative (SFISM) Program as a way to ensure the health and productivity of America's forest resources for future generations. Woodland Pulp will strive for leadership in forest management by making forest sustainability an integral part of its business strategy and using state-of-the-art forest management practices.

Best Management Practices For Water Quality (BMP):

For each state and province in which Woodland Pulp operates, Woodland Pulp will conform fully with all applicable voluntary and non-voluntary BMPs. Woodland Pulp will continue to periodically conduct BMP audits on the properties where Woodland Pulp supervises the forestry operations and as appropriate, on properties from which our open market wood is delivered.

Contractor Training:


Wood producers¹ doing business with Woodland Pulp are encouraged to obtain SFISM training. Since SFISM in an evolving program, these training requirements will be updated periodically. Procurement foresters will help provide the details of training opportunities to their suppliers. Wood producers outside of Maine and New Brunswick will be encouraged to obtain equivalent training. Woodland Pulp will promote SFISM training throughout each procurement area.

Woodland Pulp prefers to conduct business with wood producers¹ who have obtained or have maintained SFISM training.

Training, like most elements of the SFISM program, requires a team effort on the part of the entire forestry community. Woodland Pulp strongly believes that it is in the best interests of everyone – manufacturers, loggers, landowners, foresters and others – to pursue improved training in sustainable forestry.


Adverse Conditions:

To the best of our ability, and within the constraints of wood quality and physical space limitations, Woodland Pulp will plan purchases and forecast inventory levels to minimize the necessity of short-term "emergency" deliveries during times of adverse weather conditions that may increase the environmental impact of harvesting operations. Woodland Pulp encourages its suppliers to make allowances for weather related events, and will not penalize any producer for deliveries below assigned quota if the shortfall is attributed to compliance with SFISM principles or objectives. Woodland Pulp will not knowingly purchase wood from harvesting operations causing significant environmental damage as a result of adverse weather conditions or because Best management Practices are not being used.


