**CERTIFICATION OF COMPLIANCE WITH REQUIREMENTS OF THE OSHA  
PROCESS SAFETY MANAGEMENT STANDARD**

By signing the Agreement with WOODLAND PULP, LLC and ST. CROIX TISSUE, INC. Industries Inc. or its subsidiary (“the Company”) to which this document is attached, and as part of Contractor’s obligation thereunder, Contractor does hereby certify the following:

1. Contractor has inspected the job site and the area where the work is to be performed.
2. Contractor has informed the Company of any unique and/or specific hazards associated with the work.
3. Contractor has assured that it’s employees have been instructed in the known potential fire, explosion, or toxic release hazards related to his/her job. Contractor has documented that each employee has training
4. Contractor has been informed by the Company of, and has trained its employees and its subcontractors and their employees in, the known potential fire, explosion, or toxic release hazards related to the work and the process.
5. Contractor has documented that each employee has received and understood the all training received, including a record which contains the identity of the employee, the date of training and the means used to verify the employee understood the training.
6. Contractor has been informed of the applicable provisions of the Emergency Action Plan, including proper entrance, presence and exit procedures and has trained its employees with regard to these procedures.
7. Contractor has been informed of the Company’s safety rules, policies, procedures and work practices which apply to the work; has received copies of said safety rules, policies, procedures and work practices; has trained its employees as to those policies, will comply with said rules, policies, procedures and work practices in performing the work.

8. Contractor has trained each of its employees in the work practices necessary to perform his/her job safely and has ensured that its subcontractors and their employees have received such training.
9. Contractor has trained its employees in the proper use of all personal protective equipment necessary to perform safely the duties and practices involved in the performance of Contractor's work and have ensured that its subcontractors and their employees have received such training.
10. Contractor will provide additional training as necessary: a) to prepare its employees for changes in the operations or work practices at the facility and (b) to ensure that the employees' understanding of the applicable safe work practices remain current.
11. If the contractor's employees are involved in operating a process or maintaining the on-going integrity of process equipment, contractor will provide to such employees the same training that the PSM Standard requires for WOODLAND PULP, LLC and ST. CROIX TISSUE, INC. 's direct hire employees who are in operating such a process or maintaining the on-going integrity of such process equipment.

Failure to observe or fulfill any of the obligations in this Certification of Compliance will be grounds for immediate termination of the Agreement between the Company and Contractor.
